APPLICATION INSTRUCTIONS

MIXING

This product is supplied ready to use.

SUBSTRATE PREPARATION

Before applying, wet the area in question with water. May be applied to dirty and damp surfaces.

APPLICATION

Use the product neat. Mask up any adjacent surfaces to prevent damage. Protect plants and grass etc form overspray/run off. Brush or spray on the cleaner, working well into stain and leave for 15 - 20 minutes. After this time, use a hard bristle brush to remove the stain. Finally, wash down the area with water, preferably with a hose, before the product dries. Take care not to allow residues to run directly into fresh watercourses.
